Compared to last week: Hay sold fully steady. Demand for hay was remains moderate for mostly moderate offerings. Prices nearest drought stricken areas remain the highest. Heavier sales were seen this week as buyers and sellers both seem happy to move hay at steady prices. Straw demand remains good, and sales continue at steady money this week. According to the drought monitor 57.01% of the state is in Moderate drought or worse, up 14.11% from last week; 37.79% of the state is in an Severe drought or worse, up 13.36% from last week; 3.59% of the state is in extreme drought or worse; 0% of the state is in an exceptional drought, both unchanged from last week.
