## COLONY, HONEY PLANT AND MARKET CONDITIONS DURING OCTOBER 2020

**APPALACHIAN DISTRICT (MD, PA, VA, WV):** As the leaves changed color and dropped with the cooler, fall temperatures some colonies were still foraging on golden rod, aster, hardy ageratum, Russian sage, and various other fall blooming perennials. A few areas did experience a hard frost, but for most, wildflowers were still blooming into late October. Beekeepers checked on hives as treatments were finishing and sugar water was provided to prepare colonies for winter. Beekeepers will make the switch to fondant as temperatures consistently stay cool (daytimes below 50). Several associations were holding very successful and informative virtual conferences and meetings.

**ALABAMA:** Colonies in Alabama in October experienced warmer temperatures and higher precipitation compared to normal. This was largely driven by two hurricanes that moved through the state at either end of the month. As a result, nectar and pollen availability was disrupted by intense spells of rain, so flowering plants like goldenrods and asters could not contribute to colony stores. Beekeepers reported continued high levels of varroa mite, as well as small hive beetle. This latter species appeared to be lingering at higher levels further into the season when compared to previous years, possibly because of favorable weather. Physical distancing measures because of COVID-19 continued; in-person meetings were very restricted and were usually represented by small in-apiary meet-ups. Clubs conducting virtual monthly meetings reported far fewer attendees compared to in-person meetings conducted at the same time in previous years.

**ARIZONA:** Temperatures in Arizona were at above normal levels during the month of October. Dry, drought like conditions continue across the state. Seventy five percent of the state is now under extreme drought conditions.

Beekeepers are starting to make early preparations to move colonies to other locations within the state, or to other states, for pollination of nut and fruit trees. Desert plant blooms, cantaloupes and honeydews have been the largest sources of nectar and pollen across Arizona. Demand for honey remains good.

**ARKANSAS:** During the month of October temperatures were mostly below normal across most of the state. Precipitation during October was slightly below normal across most of the state. The storms that hit Louisiana veered more East and bypassed a large part of the state. According to the U.S. Drought Monitor website, Arkansas had mostly normal soil moisture for October. Too few prices exist to establish a current market price for wholesale white honey.

**CALIFORNIA:** No report issued.

**FLORIDA:** Temperatures and precipitation were about normal across Florida for the month. Bee health was considered to be about average. Brazilian Pepper was still blooming in some areas late in the month, but most Pepper honey production ended around the third week of the month. Some beekeepers were reporting lower than normal yields and also lower prices. It will be November before most of the Pepper honey is gathered from the hives and yields are fully known. An increase in imported honey appeared to be negatively impacting Florida honey prices for Brazilian Pepper. Other sources of food for the bees was Spanish Needle, Goldenrod and other assorted wildflowers. Some people were splitting hives and treating for mites in preparation for the California almond pollination season which usually begins in February. Some farmers markets opened up, but fewer consumers than normal (due to covid-19 and social distancing requirements) was making it difficult for the beekeepers to cover expenses and show a profit. Some beekeepers were also reporting problems obtaining necessary beekeeping equipment and H2A workers due to covid-19. Beekeeper associations were cancelling in person meetings and trying to hold virtual conferences. Attendance at the video conferences was very light, possibly due to a lack of technical knowledge among the participants. Lower prices over the last few months have caused some beekeepers to store some orange blossom, Gallberry or palmetto honey hoping for higher prices soon. Stored honey at the end of the month was fairly light with light supplies offered for sale at the current prices.

**GEORGIA:** Outside of having some heavy winds and rain with Hurricane Zeta passing by beekeepers are reporting that the bees are in pretty good shape and most everyone has treated and prepared the bees for winter. Fairly warm weather has been the norm, but a cold snap came through and did not stick around long enough to cause any problems. The bees are out and about still actively picking up pollen from wildflowers. Price for wildflower honey by the barrel is \$1.80 per pound

**IDAHO, COLORADO, UTAH:** During the month of October, temperatures in Idaho and Utah were above normal with parts of Utah being well above normal. Precipitation for both states was below normal. Colorado temperatures were below normal for the same time period. Colorado precipitation levels improved slightly to bring the state back to slightly below normal. According to the U.S. Drought Monitor website, Idaho had mostly abnormally dry soil moisture in October. Colorado and Utah had extreme drought to exceptionally dry conditions across most of the area.

The bees that are left in the three states have had to continue providing supplemental feed for their bees due to the dry conditions. These conditions are making it very hard for bees to find a good source of nectar. Most commercial beekeepers have shipped bees out of state trying to find better conditions. There were too few sales reported to establish a market for local honey.

**ILLINOIS:** October started out very warm and dry. As the month closed, the weather turned cold and windy. The first half of the month was somewhat dry with good rains in the middle of the month and two light snows at the end of the month. No problem with insects were reported. The bees are in much better condition than last year, when most bees were reported to have died. Several hives have an abundance of bees and need to be fed. Entrance reducers are in place for mice. Panels are inserted under IPM bottom boards. Goldenrod finished up about the 10th of the month with the first frost. So, the bees were no longer foraging. Not much honey was produced. Goldenrod did not yield heavily because it was dry at the beginning of the summer when it was being nurtured. Demand was good beginning of month but as the month progressed, sales slowed down some. There were no change wholesale or retail prices. Comb honey was reported to really have made a comeback.

**INDIANA:** The weather for October has been warm with lots of rainfall at the end of the month. Beekeepers report their bees in good condition and prepared for winter. Some beekeepers continued supplemental feeding of their bees. Beekeepers with mite problems have begun treating their hives. Demand for honey is fairly good at the retail level and demand was fairly good at the wholesale level. Prices are generally unchanged.

**IOWA, KANSAS, MISSOURI, NEBRASKA:** No report issued.

**KENTUCKY:** Kentucky has experienced a cooler-than-usual October, which weather patterns similar to 2012. Hives are going broodless much sooner than normal, and flowers have reacted by curtailing nectar production. New England asters are providing steady nectar flow, but goldenrod, wingstem, and sunflowers have definitely been impacted by the temperatures in the 20s and 30s. Varroa mite populations have been high among the beginner beekeepers, but experienced beekeepers were taking a second honey harvest.

Because Kentucky is, along with many other states, suffering another "wave" of Corona-virus outbreaks across the state, the virus continues to have an indirect effect on beekeepers, namely that many associations cannot meet at the local cooperative extension offices. As beekeeping associations plan for 2021, many are planning for virtual sessions. Kentucky State Beekeepers Association is offering 2 sets of Beginner Beekeeping courses (7 sessions each), and those filled within two weeks. On one hand, people seem to have more time to try beekeeping. On the other, getting information to them continues to be a challenge.

**LOUISIANA:** During the month of October temperatures were slightly above normal across most of the state. Precipitation during October was well above normal across most of the state again due to tropical storms hitting the coast. According to the U.S. Drought Monitor website, Louisiana had mostly normal soil moisture for October even with the storms continuing to hit the coast. Too few prices exist to establish a current market price for wholesale white honey.

**MICHIGAN:** The final feedings and winter preparation of hives are finishing up, with beekeepers busy with applying mouse guards and closing the hive entrances. Varroa mite treatments have also been applied. With the cooler weather now, most of the older bees have died off with little forage sources to sustain them. Bees were able to gather pollen from aster, mums and salvia during the month, but little nectar. With the bees now in the hive, they are clustering quietly, while preserving their health for the long winter ahead. Demand and prices for local honey have remained strong with ample supplies available. The Michigan Beekeepers Association held its fall conference virtually this month due to the COVID-19 pandemic. The two-day meeting was well-run with good guest speakers and information provided by some of the most prominent researchers in the apiary field. In the Southeast region, many of the late-blooming plants have had a little nectar and pollen as there has not been a hard frost yet. Much of the late feeding and winter prep has already been completed, with many hives looking strong and healthy, as preparations are made for the final Oxalic treatments. There has been reports of high mite loads, but many more within limits. There has been concern from some of the larger yards that CCD is on the rise: hives that looked good 2 weeks ago now have only a handful of bees.

**MINNESOTA:** During the month of October temperatures were well below normal across most of Minnesota. Precipitation was normal to slightly above normal across the state. Early ice and snowstorms accounted for most of the extra precipitation. According to the U.S. Drought Monitor website, most of the state had normal soil moisture with a few areas of abnormally dry conditions during the month.

Beekeepers reported the bees looked good going into October. As of late October, beekeepers were preparing to ship hives to warmer Southern climates. It is looking like a long winter for the state.

Demand for Minnesota honey continues to be good for locally sourced honey. Prices for 2020 new crop range mostly from \$1.45-\$1.55. There were a few reports of spot loads up to \$1.80 but that was for single load sales.

**MISSISSIPPI:** The bees are just waiting it out before the cold months come along and getting out of the hives picking up food from what is left of the Goldenrod bloom. Beekeepers report that the bees are in good condition and the hives have all been treated. \$1.85-2.00 per pound per barrel of light amber honey

**MONTANA:** No report issued.

**NEW ENGLAND:** New England weather for the month of October featured milder than normal temperatures with daytime highs in the 50s and with substantially less than normal precipitation resulting in seriously below average soil moisture levels for the entire region. Due to the warm weather, the bees have been working off the remaining late blooming floral and pollen sources such as blue gentian, buckwheat, mint especially mountain mint, wing stem, teasel, figwort, burdock, purple coneflower, heather, boneset, fireweed, ironweed, star thistle, and particularly aster and golden rod, knotweed and various fall wild flowers. Pollen and nectar sources have diminished with just a few sources remaining, which are hard to identify which ones the bees are using. Reportedly some honey robbing occurred between hives due to the weakness in population numbers in some hives and depleted nectar and food sources. Entrance reducers purportedly have been very effective in this regard.

In New England, limited pollen and nectar mean less brood and poor nutrition. This will likely contribute to creating a greater winter loss as many colonies are light and their winter bees were not developed under the best of conditions. Keepers took advantage of the later fall warmer temperatures by combining weak colonies to form strong ones and re-queen for a strong spring build up. Additionally, keepers see an advantage for a fast spring build up by wintering over with two deep hive bodies. Keepers are feeding with sugar syrup (2:1) and feed two gallons per hive before clustering as this procedure will help restore the depleted honey stores and help prevent Nosema. Keepers currently in New England have treated their hives for varroa and tracheal mites, American foul brood, wax moth, and chalk brood.

The treatments used in New England are oxalic acid, apiguard, Apistan, mite-away II, formic acid, paradichlorobenzene, and Terramycin to name the ones most popular in use. Additionally, extracted and stored honey supers are being treated with paradichlorobenzene moth flakes to kill the ever-present wax moth.

Hives are being winter prepared by shielding them with wind breaks and plastic sheeting to abate harsh wind and severe cold. Additionally, over wintering procedure entails installing mouse guards, tar paper wrapping and insulation boards between inner and outer covers and/or boards under the bottom screens to ensure that a chimney effect with cold drafty air does not occur.

The region has exhibited honey yields in all shape and sizes, occasionally spotty with underperforming hives mixed with better than expected ones, with most keepers claiming that this has been the best year ever for honey production. State inspectors report that hives are in good condition. New England Beekeeping Association zoom discussions have focused on the current fall weather conditions that New England has faced with a prolonged drought and what keepers must do to combat the seasonal rise in varroa mite populations and the particulars regarding honey extraction and needed winter preparations that must be completed in a timely way. Sustainable pest management treatment procedures are being discussed at length regarding the usage of formic and oxalic acid, considering the timeliness of fall temperatures.

Demand at the farmer's markets, and local roadside stands has been excellent and continues to remain strong. Honey sales remains very good and continues to grow as supplies of new crop, locally produced honey, in many cases, are very short and in some districts is scarce because of the demand and the mind-set that raw honey can help in the fight against the COVID-19 virus.

**NEW YORK:** The season has ended and most have honey extracted and stored. Beekeepers are finishing yard work to ensure a successful overwintering of colonies before the winter weather arrives. Both honey and pollen are needed to provide bees adequate food stores and to assist in defending the hive from infestation that would reduce the colony numbers. The honey harvest for the year was much better than the drought would have led us to believe. Stunted plants, especially goldenrod, were not expected to yield well, and Japanese knotweed (Bamboo) had a less productive season due to the dry conditions. The honey was also drier than usual. Overall, yields were average to good rather than marginal to poor with slightly different honey flavors due to weather conditions which affected floral source blends. This month, the rains have returned and begun to replenish ground water tables. As the weather cools, honey sales generally increase along with beeswax candle sales for the holidays. Honey prices have remained stable with little change from recent months. Dark honey (Bamboo) is in demand, as the crop was lower than normal. Bulk honey sales have started from those who have it to those who need it. Most report bees are healthy and ready to overwinter. The dry conditions allowed them to collect pollen from asters. Bees have been flying during warmer and drier days; however, activity has been limited as the nighttime temperatures drop with reduced day length, cutting short flight time.

**NORTH CAROLINA:** Temperatures in North Carolina were above normal for October with a statewide average temperature of 63.6°F. Precipitation was above normal, with the State experiencing remnants of both Hurricane Delta and Hurricane Zeta. Overall statewide soil moisture levels were rated 0 percent very short, 2.5 percent short, 74 percent adequate, and 23.5 percent surplus the week ending October 31. The North Carolina Drought Management Advisory Council reported zero counties as having outstanding drought or dryness.

Despite the above normal precipitation, weather in October was overall favorable for foraging, providing a continuous supply of nectar and pollen. According to apiary inspectors, October brought one of the best fall nectar flows in recent years. Bees could be seen working Aster throughout the state; Heartsease, Smartweed was available in the Piedmont region as well as Goldenrod which stretched east to the Coastal Plains region. This helped some with colony health, however, not enough for many inexperienced beekeepers that were not feeding hives when they needed it and failed to provide proper pest management. Many hives were already weakened by the effects of varroa mites and some hives continued to battle small hive beetles. On a positive note, very few colonies in central North Carolina were experiencing foulbrood disease or swarming. It was once again stated that the COVID-19 pandemic has exacerbated issues because bee schools and field days were cancelled, leaving a shortage of learning opportunities for novice beekeepers who simply did not know how to manage colony health.

Commercial pollinator hives and replacement bee operations continued to rest and replenish hives in preparation for the 2021 season. Demand for bees at this time is seasonally light as beekeepers do not want to feed and protect them throughout the winter.

Demand for honey was moderate and expected to increase during the holiday shopping season. Retail prices at the Raleigh State Farmers' Market were generally unchanged: \$7.00-\$8.00 per 8-ounce jar, \$12.00-\$13.00 per 16 ounce jar, \$20.00-\$22.00 per 32 ounce jar, and \$18.00 per 44 ounce jar; processed honey, creamed, was \$10.00 per 16 ounce jar. Prices at the Piedmont Triad Farmers' Market in Greensboro were also unchanged at: \$8.00-\$12.00 per 8-ounce jar, \$12.00-\$18.00 per 22-ounce jar, and \$20.00 per 32-ounce jar.

**NORTH & SOUTH DAKOTA:** Harvest done or nearly so for most commodities, well ahead of last season. Water resources were generally short to adequate. Beekeepers have been making preparations for winter. The bees were moving to their overwinter locations.

**OHIO:** Fall arrived with a jolt of cold, wet weather and frosts in some areas, accompanied by cloudy, gray days. The Northeast region had several early frosts, along with some warm days and abundant nectar in the long-lasting goldenrod and asters. The Southwest area had temperatures range from 55-57 degrees but little or no rainfall. According to the NWS, most of the Southwestern counties had less than .1 inch or no rain in October, leaving little nectar and some hungry bee colonies. In the North, Cleveland temperatures ranged from 35-79 degrees with 6 inches off rain. Toledo had the most rain with 10.4 inches: this area received enough moisture to obtain some nectar for feeding. Overall, heavy feeding was necessary to sustain the hives. Varroa mite populations have been high this fall partly due to the hot temperatures over the summer and kept beekeepers from treating the colonies. Robbing has become a serious problem in some areas which only increases the transfer of varroa mites and stresses the weaker colonies. In the Northwest, the fall flow was hit or miss, although with the dry weather, the hives did not lose weight as winter approaches. Brooding slowed down and with the cooler temperatures, the bees are beginning to cluster. We have had a few light frosts, but no killing frosts yet, so bees were able to continue feeding from asters and goldenrod. There is concern for mite buildups and possibility of losing a lot of hives this winter, if the hives were not properly cared for. Prices have remained stable from \$5.00-6.00 per pound wholesale and \$8.00-10.00 per pound retail. In the Southeast region, there has already been several frosts during the month and a few plants yet producing pollen that bees are able to collect. Beekeepers are now busy applying pollen patties and sugar syrup or fondant to the hives for overwintering. Yard work, applying mouse guards and winter wraps are the order of the day. The goldenrod crop was spotty in Northeast Ohio, probably a result of a dry July, and beekeepers are feeding bees going into the colder weather. Timely rains provided good moisture for goldenrod and aster honey flows. Locally adapted feral honeybees had low mite populations with high chewing behaviors. Colonies are healthy and heavy going into the winter. Commercial package bees have had high mite populations and are being fed. COVID-19 has prevented proper training for the beginner beekeepers however many state beekeeping clubs have held Zoom meetings to assist and educate the industry.

**OKLAHOMA:** During the month of October temperatures were well below normal across most of the state. Precipitation during October was above normal across most of the state. According to the U.S. Drought Monitor website, Eastern and Central Oklahoma had mostly normal soil moisture progressing to abnormally dry and extreme drought conditions as you move West. Too few prices exist to establish a current market price for wholesale white honey

**OREGON:** No report issued.

**SOUTH CAROLINA:** No report issued.

**TENNESSEE:** The fall nectar flow in Tennessee is over for all but extreme southern TN. The fall flow was one of the best we have seen in many years. Although honey production across the state appears to have been better than average this year covid-19 restrictions have caused many beekeepers to have little to no income from honey sales. Most beekeepers across the state sell the bulk of their honey at farmers markets, festivals, fairs and other venues.

Cancellation of these venues has been financially hard on the beekeepers. The number of people coming out to farmers markets has been extremely low resulting in little to no honey sales. Several beekeepers that rely on honey sales at these venues for a living have reported that many times they do not sell enough products to pay for their setup and travel to the venue.

On a positive note, beekeepers across the state are reporting that their colonies are in better shape going into the winter than they have been for many years. Hopefully this will result in stronger colonies next spring with fewer overwintering losses.

TEXAS: During the month of October temperatures were slightly below normal across most of the state. Precipitation during October was below average across most of the state. According to the U.S. Drought Monitor website, Central and Eastern Texas had normal to abnormally dry soil moisture for the month. Far West Texas had moved from abnormally dry conditions to extreme drought and exceptional drought.

October started out like a typical fall month with temperatures up and down. It ended with a large part of the state getting its first freeze of the season. Texas is unique in a lot of ways and Beekeeping is one of them. 2019 records show 132,000 honey producing colonies producing 7.4 million pounds of honey in the Lone Star state. Most of these are held in Texas over the winter and moved to other states beginning in February. Because Texas does not require apiary permitting or registration it is very difficult to keep an accurate tally of hives and production. Too few prices exist to establish a current market price for wholesale white honey.

WASHINGTON: The weather changes in late September continued and bees were able to make cleansing flights well into October. Beekeepers actively prepared the hives for winter and moved bees to their over winter locations. In late October a cold spell shut down any bee activity as well as apple harvest in many locations.

WISCONSIN: The weather has been mostly warm and dry with one significant rain. Beekeepers have treated for mites with Formic Pro and fogging with oxalic acid. Hives are thriving. Bees foraged on Goldenrod, Seven Sons tree, fall asters, some mints and white snakeroot until the first frost, then they were given supplemental feeding. Very little honey was produced, with most taken in August and September. Beekeepers are preparing for winter by insulating the hives and keeping animals away. Sales were good with no changes to wholesale or retail prices.
