COLONY, HONEY PLANT AND MARKET CONDITIONS DURING MARCH 2023

APPALACHIAN DISTRICT (MD, PA, VA, WV): March came in as a definite lion for cold (or normal) temperatures and a little precipitation and went out like the proverbial lamb. The first two weeks of March were very cold and helped to stall the progression of plants wakin g up. Bloom progression is about two weeks earlier than normal and area was still below normal for precipitation. Red Maple bloom was very good and bees were able to pull some

pollen and nectar. Spring ephemerals were blooming by mid-month to the end of the month. Beekeepers checked colonies and provided food as activity began to increase by the end of the month. Many were excited for the winter survival rate; however, a few did lose some colonies and were purchasing new bees. Although there continues to be sporadic reports of mites in some colonies, for the most part, colonies are healthy.

ALABAMA: The beginning of March continued to show signs of an early spring – temperatures were well above normal for this time of year. However, by mid-March a large temperature swing saw the entire state experience well below normal temperatures. Many locations experienced early morning frost. As a result, some forage was reduced for bees because of damage to flowers. It is also anticipated that forage into April will be negatively impacted because of damage to plants. Despite a possible lack of forage, bees continued to swarm and to produce plenty of worker and drone brood. Beekeepers will need to pay attention to nectar stores in their colonies to avoid starvation. Plants in bloom included white and red clovers in many regions of the state, whereas blackberry, dewberry, and bottlebrush trees bloomed in more southern regions. Northern regions saw callary pear, henbit and hollies bloom. Beekeepers performed swarm management, made splits, and did final varroa checks in anticipation of adding honey supers to their colonies late March or early April. Some beekeepers received packages, earlier than expected, due to warm conditions in late February and early March experienced by many package producers.

ARIZONA: No report issued

ARKANSAS: During the month of March temperatures were well above normal across most of the state. Precipitation was well above normal across most of the same area. According to the U.S. Drought Monitor website, Arkansas had normal soil moisture conditions across most of the state. Too few prices exist to establish a current market price for wholesale white honey.

CALIFORNIA: Though California beehives faced rain, snow and unusually chilly weather this March, beekeepers see plenty of potential ahead for a successful honey crop. “Last month did see some improvement in the weather,” a beekeeper said. “It finally got warmer. All the cold has delayed the sage and other plants’ development, so we will experience a delayed onset of any bloom by at least three weeks. The bees also are delaying the normal buildup, and queen availability is an issue. It should all work out if the warming continues.”

A strong mustard bloom in the valley could help bees recover from the conditions, another noted. “The amount of moisture in the soil gives us hope for good forage for the rest of the season,” he said. Unfortunately, frigid weather prevented the mating of queens and set back the production of queens and nucleus colonies in Northern California by about a month.

FLORIDA: Precipitation and temperatures were about average for the month which is warm and generally dry. The Panhandle region received some rain near the end of the month. This rain is expected to benefit the upcoming Tupelo honey season. Tupelo may start blooming earlier next month than the normal time of mid to late April due to the unexpected moisture. There were several sources of pollen and nectar. Holly, clover, black gum and wildflowers were all blooming late in the month. Some wildflower honey was produced with some extracted in March and more that will be extracted in April. Bee health was considered to be about average with some supplemental feeding needed during the month. Some of the bees returning from California almond pollination season were weaker than bees that remained in the state. This could be partly caused by weaker than normal health when they were shipped to California due to earlier storms in Florida. Orange blossom season in Central Florida was not very good this year. Shrinking groves are causing less production of pure orange blossom honey and more wildflower honey becoming mixed in with the orange honey. This reduces the value of the orange honey. As the production of orange blossom honey declines more beekeepers may elect to go to California next year and skip the orange blooming season in Florida. Most of the honey stored in Florida at the end of the month was wildflower honey produced in the Panhandle. There was not much honey produced in Central and South Florida during the month.

GEORGIA: Weather had its ups and downs with rain and some windy days along with some cold nights. Not as much freezing occurred long term, but it did hold back growth for feed in most areas after they were frozen out in February while the bees were still active in their hives and feeding off the remaining supplements. The bees are reported to be in good condition with no losses of concern as of yet. Beekeepers say they are ready for the honey flow to get going as the bees are building up favorably in numbers and condition.

Honey sold in the barrel reported as: Tupelo \$6.00, Wildflower \$3.35, Sourwood \$6.00.

IDAHO, COLORADO, UTAH: During the month of March temperatures were colder across Western and Eastern Idaho. Western Idaho had precipitation a little above normal. Eastern Idaho had precipitation far above normal. Utah had temperatures colder than normal and precipitation that was higher than normal. Colorado had a little cooler temperature than normal across the whole state. Precipitation for Colorado was above normal in western Colorado and below normal for eastern Colorado.

According to the U.S. Drought Monitor website, in March Idaho had no drought to an area of moderate drought, with most of the state under abnormally dry conditions. Utah is currently under severe to abnormally drought conditions. Western Colorado is normal soil moisture with areas of moderate to severe drought in the eastern portions of the state.

Prices for the month of March were between \$2.80 and \$3.20 per pound with a mostly price of \$2.85-\$3.00 for Idaho, Colorado prices are too few producers reporting to determine a market. Prices for locally sourced honey in Utah are \$2.80-\$3.15 per pound with mostly \$3.00.

ILLINOIS: The temperatures in March were normal with more rain than usual. During warmer days, the bees took cleansing flights. Beekeepers have been checking on the bees to see how they are doing. Most beekeepers report that most of their bees have survived the winter in good condition. Beekeepers report going to their club meetings and participating in classes. Demand for honey is good at the retail level and fairly good at wholesale level. Prices are generally unchanged.

INDIANA: The weather has been within the historical average for March with unusually large amounts of rain. Most beekeepers report that some of their bees have survived the winter in good condition, while many also report some dead hives. Beekeepers say that they have bought new packages to rebuild their hives. Demand for honey is good at the retail level and fairly good at the wholesale level. Prices are generally unchanged.

IOWA, KANSAS, MISSOURI, NEBRASKA: No report issued.

KENTUCKY: The month of March arrived like a lion and departed in much the same way: unusually strong winds, storms, and cold temperatures. Due to a historic windstorm on March 3 that affected beekeepers across the entire state, beehives were overturned, trees overturned, and electricity cut off for

more than a week for some. If beekeepers did not or could not set the hives upright immediately, the brood may have been affected by the chilly temperatures that followed the wind. Even though March was cold and chilly, inspections of beehives revealed that some hives in the southern part of the state were healthy and ready to swarm (i.e., big populations and queen cells that were 24 hours from being capped). Given the increased prices for bottles, lids, and labels for honey, the Kentucky State Beekeepers Association State Fair Committee are increasing prices of honey for the 2023 Kentucky State Fair.

LOUISIANA: During the month of March temperatures were well above normal across most of the state. Precipitation was about normal across the state. According to the U.S. Drought Monitor website, Louisiana had normal soil moisture conditions across most of the state, with a band of abnormally soil conditions along the coast.

Too few prices exist to establish a current market price for wholesale white honey.

MICHIGAN: No report issued.

MINNESOTA: During the month of March temperatures were a little colder across the state. Precipitation for March was far above normal for the state. According to the U.S. Drought Monitor website, in March the whole state had normal to abnormally dry soil moisture.

Prices per pound in Minnesota were \$2.80-\$3.75 with mostly price of \$2.80-\$3.00 for locally sourced honey for the month of March.

MISSISSIPPI: Two days of freezing temperatures in February did major damage to the bees and availability of food. The Blackberries did well but all the Popcorn trees of various sizes were frozen out and destroyed making it difficult for the bees to be able to feed and survive. All major supplies of honey appear to be out. It does not look good for the Spring flow. Privet hedge is expected to come in April. Some beekeepers are downsizing and not replacing the losses. Cost of operations have continued to increase and beekeepers can no longer absorb most of the extra expenses.

MONTANA: No report issued.

NEW ENGLAND: No report issued.

NEW YORK: March 2023 had slightly above normal cooler and wetter conditions in New York State. Maples are blooming, and fruit trees budding. The bees are actively collecting pollen. Beekeepers are installing package bees from the south, but bee stock from California is delayed due to heavy rain on the west coast. Beekeepers assessing hives in preparation for requeening or splitting hives for increase. Plans for extended release oxalic for the control of varroa mites in New York quashed when the EPA rescinded use of the application for all states that had previously approved it. Honey demand/sales good with prices holding.

NORTH CAROLINA: No report issued.

NORTH & SOUTH DAKOTA: NASS released the 2022 honey statistics. North and South Dakota had 705,000 colonies down from 2021 and represent 26% of the US total colonies. The yield per colony averaged 99 lbs. per colony down just slightly from 2021 and double the U.S. average. These yields resulted in total production of 38,415,000 pounds. This is down slightly from 2021, is 30% of the total U.S. production. The average price per pound for honey from the Dakotas was \$2.61, up nearly 30 cents per pound from 2021 and just below the U.S. average of \$2.65.

OHIO: March was an eventful month with Warmer than usual temperatures causing the Silver and Red Maple trees to bloom 3 weeks earlier than usual along with the Willow trees. With earlier pollen and nectar available to the honeybee colonies, Ohio honeybees are stronger than usual. March rain fall was above average at about 7 - 8 inches with flooding in many areas. March was very windy, with several storm winds at 30 to 40 mph with wind gusts at 60 mph. Framers were not able to work ground allowing Purple Dead Nettle to grow in many fields providing both pollen and nectar for the honeybees. Honey sales are high, price per pound \$5.50. - \$6.50 per pound wholesale, \$9.00 - \$11.00 per pound retail.

This year had initial warm temperatures quickly replaced by rain and freezing temperatures, then more rain, followed by warming slightly as a finale. The Cleveland area reached 62 degrees F on March 1st, then slowly dropped to a low of 18 degrees by March 15th. Over an inch of rain flooded streets and waterways March 3rd, which saturated the soils that then froze mid-March when 2nd on snow fell. Although snow is seldom welcome in March, the total snowfall was still 8th below the average recorded snowfall. The last few days of the month received temperatures in the high to mid-50 degrees. Toledo experienced a similar temperature swing enjoying an average of 60 degrees the day of March 1st then dropped to 37 that night. An average of 1.34" rain drenched the ground 2 days later followed by 2" snow on March 10th. March 31st averaged 62 degrees F.

The Greater Cincinnati area also began with a warm 78 degrees which plummeted to 41 degrees that night and continued to drop with 2" of rain March 3rd, an inch of snow on the 12th, then a low of 17 degrees on March 19th. Cincinnati's average temperature ended warmer with the daytime temperatures of 65, dropping to 46 degrees at night.

OKLAHOMA: During the month of March temperatures were below normal across most of the state. Precipitation was about normal. According to the U.S. Drought Monitor website, Eastern Oklahoma had normal soil moisture to moderate drought conditions. Central Oklahoma had moderate to extreme drought conditions. Western Oklahoma had mostly extreme drought conditions.

Too few prices exist to establish a current market price for wholesale white honey.

OREGON: No report issued.

SOUTH CAROLINA: No report issued.

TENNESSEE: Several beekeepers had significant losses during the cold snap in March. Colonies that looked strong and healthy prior, were dead after the cold snap. Bees had built up too much brood for the cluster size to cover the brood and still get to the honey stores and starved to death with honey

stores less than an inch from the cluster. Nectar and pollen sources for March include henbit, deadnettle, fruit trees, wild plum, maples and other wildflowers. Honey containers continue to be in low supply for honey packing due to supply chain issues.

TEXAS: During the month of March temperatures were about normal across the state. Precipitation during the month was slightly below normal for most of the state. According to the U.S. Drought Monitor website, soil moisture conditions for March did not change much from last month. East Texas had mostly normal to areas of abnormally dry conditions. Central and West Texas had areas of normal soil moisture to moderate drought with an area of extreme drought to exceptional drought continuing around the San Antonio area. Far West Texas had normal to abnormally dry conditions.

Too few prices exist to establish a current market price for wholesale white honey.

WASHINGTON: March saw more precipitation, mixed rain and snow based on elevation and proximity to the coast. Snowfall in the mountains brought snow water content to near normal in most areas. NASS released the 2022 honey statistics. WA had 86,000 colonies down from 96,000 in 2021. The yield per colony averaged 32 lbs. per colony equal to the 2021 yields. WA yields resulted in a total production of 2,752,000 pounds, down from 3,072,000 in 2021. The average price per pound for honey \$3.11, up 60 cents per pound from 2021.

WISCONSIN: The weather for March has been normal for this time of year with lots of precipitation. Beekeepers report an approximately 25 percent loss of bees over the winter. Beekeepers are trying to rebuild their populations with purchased packages. Beekeepers continue to feed their bees. Demand for honey is good at the retail level and demand was weak at the wholesale level. Prices are generally unchanged.
