

**FEDERAL MILK ORDER MARKETING AND UTILIZATION SUMMARY, MAY 2010**

**HIGHLIGHTS.** Handler reports of receipts and utilization under the Federal milk order system for May have been filed and tabulated. Combined totals for the 10 consolidated orders are being released. During May, about 11.1 billion pounds of milk were received from producers. This volume of milk is 1.6 percent lower than the May 2009 volume. In May 2010, there were significant volumes of milk not pooled due to intraorder disadvantageous price relationships. About 3.6 billion pounds of producer milk were used in Class I products, 1.0 percent lower than the previous year. Calendar composition likely had a positive impact on milk used in Class I in 2010 as compared to 2009. The all-market average Class utilization percentages were: Class I = 33%, Class II = 11%, Class III = 47% and Class IV = 10%. The weighted average statistical uniform price was \$15.03 per cwt., \$0.66 higher than last month and \$3.56 higher than last year.

3/ Due to a disadvantageous relationship between intraorder class prices and the location adjusted statistical uniform price in these markets, handlers elected not to pool an estimated 340 million pounds of milk that normally would have been associated with these markets. In May 2009, the estimated not pooled volume of milk was 60 million pounds, occurring in order numbers 030 and 032. After adjusting for non pooled milk, the year-to-year percent change is +1.3%.
